Sub: Communication of deduction of tax at source on Interim Dividend

With reference to our communication dated May 11, 2020, the Government of India has issued a press release dated May 13, 2020 to reduce the TDS rates by 25% for resident shareholders having a valid Permanent Account Number. This is to inform you that the Company shall deduct tax at source (TDS) on the interim dividend payable to the resident shareholders at the applicable revised rates subject to final notification amending the law which is still awaited. The other TDS rates and requirements specified therein shall remain unaltered.
